Course Description:

This course provides an examination of the major themes and ideas of modernism as well as a survey of its principal stylistic schools, individual artists, and key events that mark the historical development of Modern art from its origins in Impressionism through the heyday of Abstract Expressionism.

Course Goals:

Students who successfully complete this course will demonstrate competency in the following general education core goals:

- **Critical thinking skills** – Students will engage in creative and/or innovative thinking, and/or inquiry, analysis, evaluation, synthesis of information, organizing concepts and constructing solutions.
- **Communication skills** – Students will demonstrate effective written, oral and visual communication.
- **Teamwork** – Students will demonstrate the ability to work effectively with others to support a shared purpose or goal and consider different points of view.
- **Social responsibility** – Students will demonstrate intercultural competency and civic knowledge by engaging effectively in local, regional, national and global communities.

Student Learning Outcomes (aka Objectives):

Upon completion of this course, students will be able to:

- recognize and evaluate basic elements of design;
- acquire a working vocabulary associated with the analysis and interpretation of works of art;
- contrast individual works of art within their art historical contexts;
- analyze and interpret individual artist's styles and content.

Course Requirements:

Attendance

Attendance is crucial to your success in this course. Many more images are shown in class than are depicted in your textbook. Further, active-learning strategies will be routinely employed in order to facilitate a broader understanding of the material. There are no "make-ups" for these in-class activities

Paper

There will be one short Reflection Paper assigned early in the semester. Further details on the paper will be provided during the semester.

Presentation

Students will choose one artist to address in a 10-to-15-minute class presentation. Visual aids, handouts, and clear, thorough information are critical to a successful presentation. Artists will be assigned on a first-come, first-served basis. All artists are from *Arnason* and further details will be given during class.

Exams

There will be two in-class exams and one final examination. Exams will cover class lectures, textbook reading assignments, and pertinent learning material addressed throughout the semester. Exams will be made up of several sections emphasizing the strengths of various learning styles such as: slide identification, short answer, term definitions, multiple choice, and essay.
